Country information guide for migrants

The main objective of this guide, developed by UGAIN project partners, is to provide the manager of an intercultural garden, NGOs, associations, and anyone who is interested, with existing resources for the attention of the collective population of immigrants who come to our countries in search of new opportunities, trying to promote their full integration into society.

European citizens face a never before seen migration challenge of unheard of dimensions and complexity, so this manual is intended to serve as a reference when facilitating the social integration of these individuals. In many cases, ignorance of the existing resource portfolio causes us to miss opportunities in guiding and assisting the population of immigrants, who, especially at the beginning of their migration journey, need guidance focused on solving their problems.

We have divided the manual into seven parts with an appendix, each section responding to the specific and general needs of daily life in Europe, with the corresponding resources available. Due to the wide variety and complexity of the cases to be dealt with, each partner of the UGAIN project has developed the guide according to the regulations and characteristics of the host country, following a common pattern to be able to offer a complete and useful manual, which has not been created with the intention of being exhaustive or solving all the doubts that may arise within an interculture garden, but offering general and reference information where we can support the professionals of the sector in case of need.

Finally, emphasizing the hope in which this guide is derived, the result of years of work by the participating partners, with strong social character and in the hope of supporting those dreams that often stay along the way, so that one day they can become reality.



1. GENERAL INFORMATION

ĺ

People are entitled to political asylum and in Sweden this may be caused by refugees (the risk of persecution in the country of origin), the need for protection (if the person is fleeing from war or risk of death penalty or physical punishment in the home country. In particularly adverse circumstances, (e.g. serious disease.) Immigration can also be required for reasons such as looking for work, family migration, returning emigrants and adoption. The term mainly refers to people with permanent residence permits and who have or can get citizenship.

It is unclear whether the term also includes illegal immigrants, i.e. people who are permanently in the country without a residence permit, and people with impediments to enforcement against expulsion. The term generally does not refer to asylum seekers who await decisions or people with temporary residence permits. For example, guest workers, international students and migrants. A new arrival is an immigrant, usually a refugee, who has been granted a residence permit and is therefore no longer an asylum seeker, but still has the right to start-up activities.

2. HEALTH AND SOCIAL SERVICES

In Sweden, people who have been granted a residence permit are entitled to care to the same extent as Swedish citizens, while asylum seekers, irregular migrants and paperless are entitled to non-waiting care, such as emergency care and maternity care.

According to Swedish law, county councils and municipalities must offer healthcare to all residents of the county council. In addition to those who are Swedish citizens, those who have obtained a residence permit also have access to adequate Swedish health care. People who have applied for asylum in Sweden can take part of the Swedish healthcare to a certain extent and since July 2013 the same rules apply for those who stay hidden in Sweden and for the paperless.

All children have the right to health care regardless of citizenship. Asylum seekers are offered a free health examination upon arrival in Sweden and illegal immigrants and undocumented people will receive the same offer when they seek care. People who reside in Sweden without a residence permit also have the right to emergency medical and dental care, maternal health care, care for abortion and pregnancy, contraception counselling and care in connection with infectious diseases.

Asylum seekers and undocumented children under the age of 18 are entitled to healthcare and dental care on the same terms as other children in the same county council. Asylum seekers who do not understand Swedish also have the right to have an interpreter present during the doctor's visit. This service should be free of charge. In many county councils, healthcare is offered in several languages, information on this can be found on each county council's website and sometimes on the health centres' own websites.

3. JOB PLACEMENT AND LABOUR MARKET

If you want to work in Sweden and come from a country that is not a part of the EU/EEA or Switzerland, you must have work and residence permits. You also need a residence permit to start or run your own business or become a part owner of a company. If you have had a residence permit for at least five years in an EU member state but are not an EU citizen, you may be able to obtain the status of long-term resident in that country.

Long-term residents have certain rights which are similar to those of EU citizens. If you intend to reside in Sweden, you shall register at the local Tax Office. This process is called folkbokföring.


The Swedish education system in brief:

Your child can attend preschool from the time he or she is 1 year old. Play is an important element of preschool.

There is a new law from autumn 2018 for children from the age of six. It is compulsory for children to begin a preschool class.

Preschool class is a separate type of school that involves a large component of creative work and play. Preschool class is free of charge. Preschool class is a compulsory type of school. All children attend comprehensive school from about the age of 7. Comprehensive school is compulsory, and compulsory schooling applies for years 1-9.

Most young people then attend upper secondary school for three years. New arrivals who have received a permanent residence permit are entitled to begin their upper secondary education before the end of the spring term in the year they turn 20; for asylum seekers this limit is the year they turn 18. However, there are also certain requirements for recognised grades from earlier education. Upper secondary school prepares pupils for university or University College, or for going on to employment without further education.



5. FINANCIAL AID AND OTHER SERVICES INCLUDING HOUSING

Responsibilities of different authorities in the migration process.

The Swedish Migration Board is not just a link in the migration chain - their task is also to keep the chain together.

The authorities in Sweden that are affected in various ways by migration work are:

- The Swedish embassies and consulates abroad, who receive applications for visas, work and residence permits.
- The police, who are responsible for border control and for people who do not leave the country by themselves.
- The migration courts and the Migration Court of Appeal, to which the Migration Board's decision can be appealed county administrative boards, which shall work to ensure that there are preparedness and capacity of the municipalities to take on newly arrived and unaccompanied children. The county administrative boards are also tasked with coordinating the work with early efforts for asylum seekers to make the waiting time more meaningful.
- The municipalities, which receive asylum seekers who have been granted a residence permit and have a responsibility for receiving both asylum-seeking unaccompanied children and children who have been granted a residence permit.
- The county councils when it comes to care for asylum seekers
- NGOs and aid agencies, which can, among other things, provide support for asylum seekers.
- The Children's Ombudsman, the county administrative boards, the National Board of Health and Welfare and Sweden's municipalities and county councils that cooperate in the reception of unaccompanied children.

6. INFORMATION FOR VICTIMS OF ABUSE AND DISCRIMINATION

Experimental studies have proven effective in demonstrating the existence of discrimination. We know with almost complete certainty that discrimination prevents many people from getting a meaningful job and a good salary that they might otherwise have received.

At least as extensive discrimination has been experimentally demonstrated in the Swedish housing market. A similar study sent expressions of interest to advertised rental apartments from three fictional persons: Maria Andersson, Erik Johansson and Mohammed Rashid. While Maria was invited to continued contacts or to appear in 53 percent of cases and Erik in 41 percent, the same was only true in 18 percent of cases for Mohammed.

The results of experimental studies are effective in demonstrating the existence of discrimination. But they are difficult to translate into, for example, estimates of how much of the total employment gap between domestic and foreign-born people is explained by discrimination or by other factors.
